

Investment Information

The Miami Foundation offers an exceptional selection of investment pools to meet your charitable goals. Each investment pool is carefully constructed and diversified to meet a range of philanthropic goals and time horizons.

The Foundation has in place an Investment Committee that is comprised of seasoned investment and banking professionals. The Investment Committee establishes and periodically reviews and approves the Investment Policy Statement (IPS), and monitors compliance with the IPS. The Investment Committee hires, evaluates and works with a world-class Investment Consultant who acts as Foundation's outsourced chief investment officer. Our primary Investment Consultant is SEI for these multiple investment pools. J.P. Morgan manages a cash pool.

Because your Fund is pooled with \$350 million in assets under management, you will have access to greater diversification than would otherwise be possible.

As a Fundholder, you may:

- Recommend allocating the fund assets in up to two investment pools;
- Recommend a change to the investment allocation once per year; or under extenuating circumstances such as a significant change in charitable goals or time horizon.
- Recommend your own investment manager, when your Fund size is \$1,000,000 or more.
